ELIGIBILITY

Open to male and female golfers who have not reached their 19th birthday by March 25, 2012 and are not attending college or technical school. Those juniors who have graduated high school may only play the season following high school graduation. Participants must have a USGA Handicap Index and meet the USGA Rules of Amateur Status.

ENTRY FEE/DEADLINE

All players are required to submit an entry form with the entry fee of \$120 by 5:00 pm, Monday, **March 19, 2012**. Entry fee includes green fee and lunch for all rounds. Entry forms may be mailed to the VSGA (make checks payable to the VSGA) at the address below or competitors may signup online at www.vsga.org.

FIELD SIZE/FORMAT

The field will be limited to 84 players. The format of the event is 36-hole stroke play (18 holes per day).

PRIZES

The Boys and Girls Champions, as well as age group winners in the 12-13,14-15 and 16-18 age groups, will receive prizes.

CADDIES

Competitors may have caddies, but caddies must be age 18 or under.
